General Business

1. Caroline Wells, Civil Defence Coordinator:

The Kerikeri Sports Complex is happy to continue as a Community Centre in the event of an emergency. Other Centres include Frontline Church and Bay Sports (tbc), and in a bigger event, the Turner Centre.

2. Broken sandwich board sign:

Halvo Signs quote to replace the sign is \$265 + gst. Ric can fix the existing sign, although it may be slightly shorter.

3. HSNO Certificate:

Andre's representative from BOI Gas has inspected the site and the Complex is waiting for the account and certificate to be issued. The inspector noted that a foam extinguisher has been installed and this should be a powder one. Andre has spoken with Graham, who is going to arrange a swap.

4. Kerikeri Quilters:

The Board thank Kerikeri Quilters for their letter of appreciation and confirm the availability of the complex from Friday, October 24 to Monday, October 27, 2025, inclusive. The hireage is the same as previous years i.e. \$100 for a full day, \$50 for a half day (gst inclusive) and a \$200 bond. The charity of choice for 2025 is Mid North Hospice.

5. Genesis:

Genesis issued a \$150 credit for the confusion over the gst on the solar panels and have advised, effective from December 5, power charges will increase as follows (excl gst):-

6. Solar Analytics (renewal of contract):

Raewyn searched the google site for reviews and they were all negative. Solar Analytics have not responded to emails and therefore the Board will hold off renewing the subscription for the 12 month period and reassess things again in September 2025.

Lightforce has refunded the Board \$195.08 for their oversight; not advising Genesis that the Complex was gst registered.

7. Playground update:

The Resolution passed at the last meeting needed to be amended in accordance with the Pub Charity's guidelines so Ange could continue with the funding application. The Resolution was signed by Raewyn and amended as follows:-

'It was agreed at the committee meeting held on the 21st of October 2024 of the Kerikeri Sports Complex to apply to Pub Charity Limited for a Grant of \$77,567.00 to cover the costs of playground equipment.'

Ange confirmed she received \$40,000 from Pub Charity Limited and the Lotteries Commission funding application will be confirmed on Friday, December 5th.

8. Laser Electrical:

Raewyn emailed Laser to query the additional account of \$125.35, who, 'as a good will gesture, will credit the invoice'.

9. KKHS Netball Development Team's Australia tour:

The Board thank and accept KKHS's offer to be included as a sponsor on the players and coaches uniform and understand there is no cost to the Board.

10. Rugby League Northland:

League have booked the fields and changing rooms on Sunday, March 23, 2025, from 8am to 4pm. They are expecting 150 people. The hireage is \$125 for the fields with a \$200 bond. Strictly no alcohol on site.

11. Fulton Hogan:

Further to Fulton Hogan's enquiry to hire the fields and netball courts for approximately 200 people for three hours, the Board would prefer Fulton Hogan either hire portaloos or pay to use the netball/squash toilets as the 24 hour toilet is not suitable for this number of people. The Board confirm the hireage for Fulton Hogan is:-

13. Touch Rugby:-

15. Vacuum cleaner:

The vacuum has been with Stihl, Waipapa awaiting parts since May 2023. Once the new switch was installed, it was discovered the motor was burnt out and the vacuum is not repairable. This is due to the extended power lead and the draw of electricity on the motor.

Due to the length of time it has taken to get to this point, the Board accept Stihl's offer to sell the Complex a new SE133 vacuum at half price and will ask for the return of the old vacuum. New vacuum's currently retail at \$1,225.
